The Principal, Sree Narayana College, Kollam has requested for clarification regarding the eligibility of Refresher/Orientation/Short Term Courses conducted by agencies other than UGC HRDC to be considered for CAS placement of teachers in Private Aided Colleges, vide paper read as (1) above.

The Syndicate, vide paper read as (3) above, considered the above matter along with the recommendations of the sub committee constituted for studying the eligibility of Orientation/ Refresher/ Short Term Courses conducted other than those offered by UGC HRDC for placement of teachers, and resolved to reckon the following Orientation/Refresher/ Short Term Courses, conducted by the respective agencies, be considered eligible for the CAS promotion of teachers in Private Colleges:

- 1. The Refresher/Orientation/Short term Courses run by HRDCs and their associated institutions.
- 2. The Refresher/Orientation/Short term Courses run by State/Central Universities and its Departments, Teaching Learning Centres (TLC) under PMMNMTT, Teaching Learning Centres under State/Central Governments.
- 3. The Refresher/Orientation/Short term Courses run by Centres of Excellence and Research Oriented Institutions.
- 4. The Refresher/Orientation/Short term Courses coordinated by colleges in association with Government agencies like DCE, KSHEC, HRDC, KSCSTE, University and University Departments.
- 5. Eligibility of courses run by institutions other than the above can be considered only with the concurrence of UGC.

Sanction has been accorded by the Vice Chancellor for implementing the above resolution of the Syndicate.
