ORDER

Government as per the orders read as first and second paper above, have issued orders for implementing the Seventh UGC Pay Revision for teachers in Universities under Higher Education, Affiliated Colleges, Teachers in Law Colleges and Engineering Colleges, Kerala Agricultural University, Kerala Veterinary and Animal Sciences University, Kerala University of Fisheries and Ocean Studies and teachers in Physical Education and Librarians etc.with effect from 01.01.2016. In the order read as first paper above, it has been ordered that the arrears for the period from 01.01.2016 to 31.03.2019 shall be taken later subject to the release of Central assistance in this regard and the fiscal position of the State.

(2) Comptroller, Kerala Agricultural University,as per the letter read as 3rd paper above, has submitted a proposal requesting to release an amount of ₹12,69,95,252/-,ie., 50% of the total dues payable to Kerala Agricultural University teachers from 01.01.2016 to 31.03.2019, to avoid loss of Central share in respect of implementation of 7th UGC Pay revision in Kerala Agricultural University.

(3) Government have examined the matter in detail and are pleased to accord sanction for the release of 50% (fifty percentage) of the state

share of the arrears of the 7 th UGC Pay Revision for the period from 01/01/2016 to 31/03/2019 to the Kerala Agricultural University; amounting to ₹12,69,95,252/- (Rupees Twelve Crores and Sixty nine Lakh Ninety five Thousand Two Hundred and Fifty two only) from the budget allocation of Kerala Agricultural University under the H/A 2415-01-277-99-31-Grant-in-Aid General Salary(NP) .

(4) The funds shall be released by debiting the expenditure under the head of account "2415-01-277-99-31-Grant-in-aid General salaries-(NP)" depositing in the Special TSB Account No.713031400000005 of the Comptroller, Kerala Agricultural University at Additional Sub Treasury, Thrissur.

(5) The amount will be paid by the Sub-Treasury Officer, Secretariat Treasury, Thiruvananthapuram in a bill drawn by the Under Secretary of Agriculture (Farms) Department, Government Secretariat, Thiruvananthapuram.

(6) Kerala Agricultural University should inform ICAR directly about the receipt of the state share and immediate action should be taken to get the Central share sanctioned. The crediting of the outstanding amount to the employees' PF will be decided by Government after receiving the central share.
