**Subject: Reimbursement of financial burden due to implementation of Revised Pay Scales on the basis of 7<sup>th</sup> Pay Commission recommendations for Teachers and equivalent Cadres in Universities and Colleges from 01.01.2016.**

Sir/ Madam,

I am directed to refer to this Department's letters of even number dated 24<sup>th</sup> February, 2022 and 10<sup>th</sup> March, 2022 (copies enclosed) regarding reimbursement of 50% central share by the Central Government for implementation of scheme of revision of pay (7<sup>th</sup> CPC) for teachers and equivalent cadres in State Universities and colleges.

2. In this regard, it is stated that with the approval of the Ministry of Finance, the last date for submission of complete proposals by the State Governments under the scheme was extended upto 31.03.2022 for reimbursement of 50% central share under the scheme, subject to the condition that expenditure on this account up to the period 31.03.2019 only will be eligible for reimbursement. The State Governments were requested to take necessary action and submit complete proposal for reimbursement of 50% central share under the scheme on or before 31.03.2022.

3. This Ministry has several times extended the last date of the scheme for submission of complete proposals by the States, till last extension upto 31.03.2022. Though this Department has received several proposals from the States, however, most of the proposals submitted by the States were not complete/ correct as per this Ministry's orders mentioned hereinabove. Therefore, the central share could not be reimbursed. Further, as the last date for submission of complete proposals by the States was 31.03.2022, the proposals of States received after 31.03.2022 have not been considered for reimbursement under the scheme.

4. In view of the above, it has been decided to close the scheme for reimbursement of 50% central share for implementation of revised pay (7<sup>th</sup> CPC) for teachers in State Universities and colleges to State Governments with effect from 01.04.2022.
