## **ORDER**

As per Government Orders read as 4<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 11<sup>th</sup>, 12<sup>th</sup>, 14<sup>th</sup> and 18<sup>th</sup> above, Government had issued orders revising the pay and allowances of teaching staff of Universities in the State and affiliated colleges both under Government and aided sector and in all streams of education, and Qualified Librarians as per 7<sup>th</sup> UGC/AICTE Regulations. Subsequently, as per the Government Orders read as 15<sup>th</sup>, 16<sup>th</sup> and 17<sup>th</sup> above, Government had clarified/ regulated certain common issues in the above pay revisions.

2. As per Government Order read as 16<sup>th</sup> above, the benefit of incentive advance increments available under 6<sup>th</sup> UGC/AICTE Schemes for acquiring higher qualifications like Ph.D and M.Phil was extended up to 01.11.2017. Vide clause 8 in the Notification read as 2nd above, it was clarified that there should be no incentives in the form of advance increments for obtaining the degrees of M.Phil or Ph.D since the incentive for higher qualification is built-in in the pay structure itself, wherein those having M.Phil or Ph.D degrees would progress faster under CAS. But contrary to the above Notification, the provision for advance increments had been included in the 7<sup>th</sup> Regulation issued subsequently by the UGC and the AICTE on 18.07.2018 and 01.03.2019 respectively. In view of lack of clarity in the issue, Government sought clarification from Government of India regarding the admissibility of advance increments for higher qualification under 7th UGC/AICTE pay

revision. In the context of non receipt of any reply from the Government of India, State Government, vide the order read as 16<sup>th</sup> above, had clarified that the incentive increments for M.Phil, Ph.D etc. would be admissible only up to 01.11.2017 and the same would also be allowable only at the pre-revised rate.

- 3. In the consideration of representations from various service organisations and court cases filed against Govt; in this matter, Government constituted a committee to examine the issues in the implementation of 7th UGC/AICTE Schemes in the State thoroughly. Later, as per letter read as 19<sup>th</sup> above, the University Grants Commission informed unequivocally to follow clause 8 in the communication of Ministry of Education dated 02.11.2017.
- 4. In view of the clarification from University Grants Commission and on the basis of the report of the officers' committee constituted to study the issue, Government examined the matter in detail and are pleased to issue the following orders.
  - i. The benefit of advance increments for higher qualification of M.Phil, Ph.D etc. sanctioned during 7th UGC/AICTE period, as per the Government Orders read above, shall be withdrawn with effect from 01.01.2016.
  - ii. The excess amount, if any, received in the above connection may be adjusted in the arrears of DA revision/arrears of promotions, as the case may be.
  - iii. From the next UGC/AICTE pay revision onwards, an official committee system should be instituted in FD, including the representatives of stake holding departments suitably, in order to make an in depth study of various aspects in the implementation of UGC/AICTE pay revisions in the State, such as, the academic requirement, capacity of the State Finance to absorb the additional

financial commitment due to the revision and the resultant financial commitment, so as to avoid ambiguities and implementation issues in the realm in future. The implementation of UGC/AICTE regulations in the State will be considered by Govt; only on the basis of the recommendation of this Committee. It is also made mandatory that the issuance of orders for UGC/AICTE pay revisions in the State should be from Finance Department.

iv. The Heads of Department of the teachers/officers who have enjoyed the benefit of incentive advance increments for higher qualification under the 7th UGC/AICTE pay revision, should take steps to get their pay modified as per this order, without any formal application from the teachers/officers concerned and in consultation with the Accountant General (A&E), within a period of six months from the date of this order.

5. The Government Orders read above will stand modified to the extent at which the orders herein is issued.
