### ORDER

As per the Government Order read 2<sup>nd</sup> above, 7<sup>th</sup> UGC Scheme was implemented for Universities under Higher Education, affiliated colleges, teachers in Law Colleges, Engineering Colleges, Agricultural University, Kerala Veterinary and Animal Sciences, Kerala University of Fisheries and Ocean Studies, teachers in Physical Education and Librarians etc. As per the Government Order read 3<sup>rd</sup> above, Government have issued clarifications to 5<sup>th</sup>, 6<sup>th</sup> and 7<sup>th</sup> UGC/AICTE pay revision orders in connection with reckoning of prior service for Career Advancement Scheme (CAS) placements under UGC/AICTE Schemes. Vide para 3(i) of the said GO, it was clarified that previous teaching/non teaching services rendered in all types of institutions both within and outside the State should not be counted for CAS placements under 6<sup>th</sup> and 7<sup>th</sup> UGC/AICTE Schemes, on getting another appointment in institution under Government/Aided in the State, during the 6<sup>th</sup> and 7<sup>th</sup> UGC/AICTE periods. Later, as per Government Order read 4<sup>th</sup> above, para 3(i) of the Government Order read 3<sup>rd</sup> above was deleted with a view to reconsider the matter afresh.

2. Having examined the matter in detail, Government are now pleased to issue the following orders in partial modification of the Government Order read 2<sup>nd</sup> above, in making the facility for reckoning the previous service for direct recruitment and CAS placements available under 7<sup>th</sup> UGC scheme period, to the extend the clause 10 of the UGC regulation read 1<sup>st</sup> above modified as detailed below.

- i. Previous regular service as Assistant Professor, Associate Professor or Professor or equivalent only in Universities established by the Central or State Governments and in Government Colleges and Aided Colleges coming under the direct payment system will be eligible to be counted for the direct recruitment and promotion under CAS of a teacher as Assistant Professor, Associate Professor, Professor or any other nomenclature, under the 7<sup>th</sup> UGC Regulation period.
- ii. The selection and appointment to post in which the previous service rendered should be made in accordance with the prescribed selection procedure as laid down in the UGC Regulation.
- iii. The above provision has only prospective effect and will render only prospective benefits, both monetary and others.

3. No other provisions in clause 10 of the regulation read 1<sup>st</sup> above beyond the modified clauses prescribed under para 2 above will be applicable for the direct recruitment and CAS promotions in the educational institutions defined under para 2(i) above.

4. The Government Order read as 2<sup>nd</sup> paper above stands modified to this extent.
